

To the Domain of Glasgow,

I became your Prince only a few short months ago and the myriad of things within it that require the direct attention of Kindred is staggering. More urgently now are the elements that require sed attention and currently lack it. The first thing I make clear, for the security and future of this Domain, is that I will not tolerate dead weight. Put as simply as I can, if you are not contributing to the strength and stability of this Domain then you will be exiled to another Domain.

To facilitate this change in management style there will be alterations on how the Domain functions both in regard to the individual Kindred and us as a whole. The first change that some may know about already is the return of the Primogen Council. Currently these stand as Levi Tius of Clan Tremere, Finn Huxley of Clan Ventrue and of course my Seneschal Ethan Fletcher of Clan Malkavian. Over time I may bring more into this group as Kindred prove themselves up to the responsibilities. The duties of the Primogen are to act as the bridge between myself and those in my Domain who lack the Status to have my ear. If there is an issue within the Domain that is not easily within the duties of other Court Officers then it should be passed to the Primogen. They will also be the task leaders for any ongoing large scale activities within the Domain and will oversee their function and completion in order to better assess those involved with the action, either good or bad. The Primogen may also seek my attention during courts without first addressing Seneschal Fletcher.

The second change is a matter of domains and residency. I stated at the last court but not all were present so I will say again here so there can be no confusion. Other than the domains I gave at my last court, all other domains, contracts and agreements are revoked. If you had any of the above under an old Prince you will be required to re-negotiate that with me if you want to keep it. This is in order to set the field the way I want it as the scope of domains has also changed. It is no longer simply geographical areas but also a matter of influences within the Domain. The aim is for everyone to work towards something that is theirs that they can focus on so that strength and stability can be built. Those who have been given domains already and those who get them in future will be required to attain full control of the domain within Glasgow.

It was also stated last month to some so I was say again here to clarify, any Kindred of the Camarilla who does not meet with me within three months of my February Court will be subject to a Trial, Exile or Destruction.

My next point is more of a clarification. Adam Edelstein before he left brought forward a practice performed in many Domains and that is Trials. If you are subject to a Trial your terms will be set and should you pass the trial the crime for which you were given the Trial you will be given leniency. Failure of a Trial for a minor crime will come at the cost of prestation to me as well as any you may have offended to cause the Trial or Exile from the domain. Failure of a Trial of a serious crime will result in Destruction.

The final point in this letter is more immediate and is relevant to all Kindred within the Domain. It has come to my attention and the attention of my Court Officers that there are still events within the Domain that are undesirable and not caused by the Camarilla. I strongly suspect there are Sabbat elements within the Domain as well as other, more esoteric threats. Therefore I task every member of my Domain to become educated in the ways the Sabbat operate. Any Kindred of my Domain who cannot demonstrate a working knowledge of Sabbat operations within six months will be deemed as dead weight and will be subject to a Trial and possibly Exile. I will personally be holding lessons for those who wish to learn so I advise you arrange to speak with me soon. The longer that time passes the more expensive my service will be.
